2023-25 CAPITAL BUDGET HIGHLIGHTS PROPOSED COMPROMISE (ESSB 5200 as Amended)

OVERVIEW

Debt Limit

Washington State has a constitutional debt limit. The State Treasurer may not issue any bonds that would cause the debt service (principal and interest payments) on any new and existing bonds to exceed this limit. Under a constitutional amendment approved by the voters in 2012, the state debt limit is currently 8.25 percent of the average of the prior six years' general state revenues, defined as all unrestricted state tax revenues. This limit is reduced to 8 percent beginning on July 1, 2034.

Bond Capacity

A model administered by the State Treasurer's Office is used to calculate the available bond capacity for the current budgeting period and for future planning. The model calculates the actual debt service on outstanding bonds and estimates future debt service based on certain assumptions, including revenue growth, interest rates, rate of repayments, rate of bond issuance, growth of future capital budgets, and other factors. The proposed compromise budget is based on the March 2023 revenue forecast updated for January bond sales.

For the 2023-25 biennium, the total projected bond capacity is \$4.8 billion. This amount is derived from the debt model (\$4.2 billion), under spending and other adjustments in the 2023 Supplemental (\$127 million), expiring three bond authorizations where projects have been completed (\$10.5 million debt limit and \$755,000 non-debt limit), and a one-time reappropriation reversion (\$400 million). The under spending and other adjustments in the 2023 Supplemental and is largely attributed to an under expenditure in the 2021-23 School Construction Assistance Program. The three expiring bond authorizations are from Flood Hazard Mitigation bonds issued in 2008, School Construction Assistance Program bonds issued in 2009, and Skill Center Facility bonds issued in 2008. The one-time reappropriation reversion comes from a difference in the amount of bonds authorized versus the amount of appropriations expended prior to 2021. This difference has not been reflected in the calculation of available debt capacity under the state debt limit, which has resulted in an understatement of available debt capacity of the state.

2023-25 New Appropriations

The proposed compromise capital budget (Engrossed Substitute Senate Bill 5200 as amended) authorizes \$9.0 billion in total budgeted funds, of which \$4.7 billion is debt limit bonds for the 2023-25 biennium. The remaining amounts are \$947 million in federal funds, \$328 million in Model Toxic Control Accounts, \$717 million in Climate Commitment Accounts, \$295 million in alternate financing authorizations, \$275 million in State Common School Construction Account, and \$1.8 billion in all other funds.

Approximately \$95 million in bond capacity is reserved for a supplemental capital budget.

Prior Biennium Appropriations

The 2023-25 biennial budget includes reappropriations totaling \$7.6 billion for prior authorized, but not yet completed projects, of which \$3.7 billion are financed with debt limit bonds.

The 2023 Supplemental reduces debt limit bond spending for the 2021-23 biennium by \$111 million.

There is \$15.9 million in debt limit bond capacity from bonds previously authorized.

BEHAVIORAL HEALTH

\$884 million is provided to address behavioral health needs across the state. Major investments include:

State Behavioral Health Facilities

- \$613 million to the Department of Social and Health Services (DSHS) for phased construction of a new 350-bed forensic hospital at Western State Hospital;
- \$21.1 million to DSHS to rapidly increase bed capacity at Maple Lane to address bed shortages at Western State Hospital;
- \$20.6 million in additional funding for DSHS to construct a 48-bed community civil behavioral health facility in Clark County; and
- \$5 million for capital grants to entities for the procurement or renovation of facilities for the treatment of individuals committed to DSHS.

Community-Based Behavioral Health Investments

- \$211 million for competitive grants and individual projects that create new community behavioral health capacity; and
- \$13.4 million for the Rising Strong project to provide family-centered drug treatment.

AFFORDABLE HOUSING AND HOME UPGRADES

\$693.7 million is provided for affordable housing projects that construct new units, preserve and rehabilitate existing units, connect affordable housing developments to infrastructure, and provide weatherization and energy efficiency upgrades to low-income households.

Affordable housing investments include (\$570 million):

- \$400 million to the Housing Trust Fund;
- \$60 million to connect affordable housing developments to infrastructure;
- \$50 million for projects designed to increase the supply and affordability of transit-oriented housing;
- \$40 million for the Housing Finance Commission Land Acquisition Program;
- \$14.5 million for youth shelters and housing; and
- \$5 million for landlord mitigation.

Home upgrade investments include (\$124 million):

- \$83.2 million in federal authority to implement the Home Efficiency Rebates Program;
- \$35 million in weatherization and home health improvements to homes occupied by low-income households; and
- \$6 million for the Low-Income Rural Rehabilitation Grant Program.

OTHER HUMAN SERVICES

\$407 million is provided to address other human services not mentioned above across the state. Major investments include:

- \$54.9 million to the Department of Health for projects to expand and improve operations at the Washington State Public Health Laboratory in Shoreline;
- \$19.3 million to the Department of Veterans' Affairs for upgrades to veterans' homes and cemeteries across the state, including the retrofit of the heating, ventilation, and air conditioning system at the Washington Veterans' Home in Port Orchard;
- \$8 million to the Department of Children, Youth, and Families to increase campus security at Echo Glen Children's Center;
- \$3.3 million to the Criminal Justice Training Commission to expand regional training facilities to address the backlog of training for new officers in basic law enforcement academy and conduct a predesign for the main criminal justice training campus; and
- \$72 million to the Department of Corrections for projects to address critical infrastructure needs and improve safety at correctional facilities across the state.

EDUCATION

\$872 million is provided for K-12 education across the state, including \$588 million in state matching grants for the School Construction Assistance Program.

Additional investments include:

- \$100 million for small district and state tribal compact school modernization grants to repair or replace significant building systems in school facilities;
- \$41 million to complete the West Sound Technical Skills Center Modernization project;
- \$40 million in school seismic safety grants for planning and seismic remediation;
- \$21.7 million for distressed schools to address student capacity needs, safety, and inadequate building systems in school and skill centers facilities; and
- \$80.2 million in other education grants covering health and safety, career preparation, and agricultural science in schools.

HIGHER EDUCATION

\$1.5 billion in total funds, of which \$869 million is state general obligation bonds, is provided for higher education facilities at the four-year institutions and the Community and Technical Colleges. Major investments include:

- \$235 million for the University of Washington's major projects, as well as minor works and infrastructure projects;
- \$156 million for the Washington State University's major projects, as well as minor works and infrastructure projects;

- \$309 million for the regional university's major projects, as well as minor works and infrastructure projects; and
- \$448 million for community and technical college major projects, as well as minor works and infrastructure projects.

NATURAL RESOURCES

\$2.4 billion is invested in natural resource projects that collectively address water quality and supply, salmon recovery, outdoor recreation and conservation, state trust lands, state parks, air quality, and more. Major investments include:

Water Quality

- \$670 million for the Water Pollution Control Revolving Program;
- \$68 million for the Stormwater Financial Assistance Program; and
- \$40 million for the Centennial Clean Water Program.

Salmon Recovery

- \$95 million for the Salmon Recovery Funding Board;
- \$67.4 million for the Floodplains by Design Program;
- \$73.5 million for the Puget Sound Acquisition/Restoration and Estuary/Salmon Restoration Programs;
- \$50 million for riparian restoration grants;
- \$48.4 million for the Brian Abbott Fish Barrier Removal Board; and
- \$44 million for the Duckabush Estuary Restoration Project.

Water Supply

- \$70 million for the Chehalis Basin Strategy;
- \$60.7 million for the Columbia River Water Supply Development Program;
- \$49 million for the Yakima River Basin Water Supply;
- \$40 million for the Streamflow Restoration Program; and
- \$14 million for the acquisition of Springwood Ranch.

Outdoor Recreation and Conservation

- \$120 million for the Washington Wildlife and Recreation Program;
- \$12.5 million to improve equitable access to community outdoor athletic facilities;
- \$10.4 million for Youth Athletic Facilities; and
- \$7.8 million for the Community Forests Program.

Toxic Cleanup and Prevention

- \$115 million for Remedial Action Grants;
- \$12.3 million for Affordable Housing Cleanup Grants;
- \$12 million for removing, remediating, or upgrading underground storage tanks;
- \$9.8 million for projects that mitigate PFAS contamination and to conduct a statewide PFAS funding strategy;
- \$5 million to remediate soil contaminated with DDT pesticides in Okanogan County; and

- \$4 million for the Swift Creek Natural Asbestos Flood Control and Cleanup Project.

State Parks

The State Parks and Recreation Commission receives \$81.6 million for projects that include parks preservation and enhancements, facilities repair, and development of Nisqually State Park.

Carbon Sequestration Forests and Trust Lands

- \$83 million to purchase and improve forestland for the purpose of carbon sequestration and conduct related research and analysis;
- \$19.6 million for trust land transfer projects;
- \$7.5 million for state forest land transfer of encumbered lands; and

Air Quality

- \$21.8 million to improve air quality in overburdened communities and establish ultra-fine particle monitoring in the Puget Sound region;
- \$19.8 million to reduce diesel greenhouse gases and toxic wood stove emissions; and
- \$15 million to capture methane emissions from municipal landfills.

GENERAL GOVERNMENT

Amounts are appropriated for a variety of investments in clean energy, public infrastructure, community enrichment, and state facilities. Major projects are as follows:

Local and Community Projects

- \$231 million for the Department of Commerce to make grants to local governments and nonprofit organizations statewide for over 325 community-based projects;
- \$38.9 million for projects addressing health care infrastructure or increasing health care availability;
- \$17.6 million in community grants to increase access to dental care;
- \$30.6 million for competitive grants for social service and multipurpose community centers; and
- \$8 million for recreational facilities for youth.

Clean Energy, Energy Efficiency, and Rehabilitation

- \$163 million for the Home Electrification and Appliance Rebates Program (HEAR);
- \$60 million for grants from the Clean Energy Fund;
- \$39 million in large scale solar innovation projects; and
- \$36.7 million in local emission reduction projects and projects to reduce emissions in hard to decarbonize sectors.

Early Learning Facilities Grants

- \$60 million for grants and loans to purchase, construct, or modernize facilities to add capacity for early learning programs, including the Early Childhood Education and Assistance Program;
- \$5.4 million for early learning facility grants to school district; and

- \$5 million for grants to child-care providers for minor renovations and small capital purchases and projects.

Local Infrastructure

- \$400 million from the Public Works Trust Fund for infrastructure projects administered through the Public Works Board;
- \$140 million for low-interest loans to publicly and privately owned drinking water systems through the Department of Health; and
- \$50 million for state matching funds for the federal Broadband Equity, Access, and Deployment Program.

Arts & Historic Preservation

- \$18 million for performing arts, museums, and cultural projects under the Building for the Arts Program; and
- \$5.2 million for grants to preserve heritage barns, historic cemeteries, historic county courthouses, and historic theatres.

Military Department

- \$54 million for the design and construction of a new National Guard Joint Force Readiness Center at Camp Murray;
- \$6 million to address water mitigation issues in North Bend in preparation for the future site of the King County Area Readiness Center; and
- \$5.5 million for renovation of the Moses Lake Readiness Center.

Other State Facilities

- \$113 million for the legislative campus modernization project;
- \$15.8 million for the Washington State Patrol to move forward with land acquisition and design for two consolidated crime laboratory facilities along the Interstate-5 corridor; and
- \$2.7 million to begin renovation of the legislative building centennial skylights.
